**Working place:** CGPP, IBMC, I3S (Instituto de Investigação e Inovação em Saúde, Universidade do Porto, Rua Alfredo Allen, 208, Porto) supervised by Dr. Isabel Alonso

**Summary of work program:** GenomePT is the Portuguese distributed infrastructure for genome sequencing and analysis that has been included in FCT's Infrastructure Road Map. This infrastructure aims to potentiate the participation of Portuguese scientists in national and international genome projects, and to promote genomics research in relevant fields such as healthcare and drug discovery.

**Candidate profile:** We are looking for a candidate with MSc in Bioinformatics or related field of study, knowledge in appropriate programming languages and previous experience with bioinformatics tools. Highly desirable skills include background and good knowledge in Human Genetics, previous experience with online genomics databases and bioinformatics tools for the analysis of next-generation sequencing data, and experience in variant interpretation and classification.

**Application procedure:** To apply for the Bioinformatician Position applications should include a letter of motivation, Curriculum Vitae, Master Certificate and at least one reference letter. They must be submitted between the 24th of July and the 31st of August 2017 on the IBMC webpage:

**Evaluation of applications:** The candidates with the required profile will be selected based on the written documentation (CV (35%), motivation letter (5%) and references (10%)). The most qualified candidates from the initial selection will be then subjected to a final selection step based on a personal interview (50% to sum up with the evaluation of the written documents).

Jury: President – Jorge Sequeiros (PhD); Ordinary members – Isabel Alonso (PhD) and Paulo Silva (PhD).

**Results:** The final results are announced at the IBMC web site, and the selected candidate contacted via e-mail.

**Contract conditions:** The contract is expected to start in the 15th of September, 2017 and will be initially for 12 months, eventually renewable. The salary is 1373,12 Euros/month (before taxes) and regulated by the Portuguese Labour Law.
