



ANNOUNCEMENT FOR THE OPENING OF AN INTERNATIONAL SELECTION TENDER PROCEDURE FOR DOCTORATE HIRING OF DECREE-LAW NO. 57/2016 OF 29 AUGUST, amended by 57/2017 Law of 19 July.

1. The meeting of the Board of Directors of IBMC deliberated the opening of an international selection tender for 1 vacancy of doctorate to perform duties of scientific research in the scientific area(s) of **biochemistry**, under a work contract with non-fixed term under the Portuguese labor Law in order to perform duties, as researcher within the project with the reference NORTE-01-0145-FEDER-030507 and the title "**Molecular mechanisms of the dynein-dynactin transport machinery in health and disease**" at IBMC, financed by FEDER - Fundo Europeu de Desenvolvimento Regional funds through the Norte Portugal Regional Operational Programme (NORTE 2020), Portugal 2020, and by Portuguese funds through FCT - Fundação para a Ciência e a Tecnologia/Ministério da Ciência, Tecnologia e Ensino Superior.

2. Description of position

The postdoctoral position is available in the Cell Division Mechanisms group headed by Reto Gassmann at the Institute for Research and Innovation in Health in Porto (https://www.i3s.up.pt/cell-division-mechanisms).

Our group is interested in cytoplasmic dynein 1, an essential microtubule-based motor complex whose functions include the long-range transport of diverse intracellular cargo. The successful candidate will address how dynein and its obligatory co-factor dynactin are recruited by adaptor proteins that confer cargo specificity and help activate the motor. He/she will express and purify recombinant proteins using the baculovirus-insect cell system and characterize protein-protein interactions *in vitro* using biophysical approaches such as surface plasmon resonance.

3. Applicable Legislation

- Decree-Law no. 57/2016 of 29 August, amended by Law 57/2017 of 19 July, which approved the doctorate hiring regime destined to stimulate scientific and technological employment for all knowledge areas (RJEC),
- Portuguese labor law
- Regulatory Decree Nr 11-A / 2017, of 29th December.

5. Workplace shall be at IBMC, Rua Alfredo Allen, 208, Porto. Group: Cell Division Mechanisms under the supervision of Reto Gassmann

6. Monthly remuneration: gross monthly remuneration is 2.128,34€, in accordance with subsection a), section 1, article 15 from Law nr 57/2017, 19th July, and with the remuneration position at initial level predicted in article 2 of Regulatory Decree nr 11-A/2017, of 29th December, correspondent to level 33 at Tabela Remuneratória Única, approved by Order nr 1553-C/2008, 31st December, with the category Junior Researcher.

7. Any national, foreign and stateless candidate(s) who hold a doctorate degree in biochemistry or related scientific area and a scientific and professional curriculum whose profile is suited for the activity to be performed can submit their applications. In the event the doctorate degree was awarded by a foreign higher education institution, said degree must comply with the provisions of Decree-Law no. 341/2007 of 12 October, and all formalities established therein must be complied.

8. Tender admission requirements:

The candidate should be a motivated scientist willing to work in a highly competitive research area and must have a solid background in molecular biology and biochemistry. Experience with protein expression using the baculovirus-insect cell system, with protein purification methods (including size exclusion chromatography), and with biophysical techniques for characterization of protein-protein interactions (including surface plasmon resonance) will be highly valued. Good verbal and written communication skills in English are essential.

9. Pursuant to article 5 of RJEC, selection is to be made based on candidate scientific and curricular career evaluation.

10. Scientific and curricular career evaluation focuses on relevance, quality and up-todateness:

a) of scientific, technological, cultural or artistic production in the last five years, deemed most relevant by the candidate;

b) of research activities, applied or based on practical work, developed in the last five years, deemed most impactful by the candidate;

c) of knowledge extension and dissemination activities developed in the last five years, namely under the scope of the promotion of culture and scientific practices, deemed most relevant by the candidate.

11. The five-year period mentioned above can be extended by the panel, if requested by the candidate, whenever the suspension of scientific activities is reasoned by socially protected grounds like paternity leave, long-term serious illness, and other legal situations of unavailability to work.

12. Evaluation criteria are the following:

a) Curriculum vitae

- research expertise with relevance for this position, in particular protein expression/purification (60%)

- list of publications in international peer-reviewed journals (20%)

b) Motivation letter

- interest for the research topics covered by this position and willingness to work in a highly competitive research area (10%)

- excellent communication skills in English (10%)

13. Candidate final classification system shall be given based on a scale 0-100.

14. The panel shall deliberate by means of roll-call vote justified under adopted and disclosed selection criteria, with no abstentions allowed.

15. Minutes of panel meetings shall be executed and shall include a summary of all occurrences of said meeting, as well as of all votes casted by the members and respective reasoning, and shall be provided to candidates whenever required.

16. After selection criteria application, the panel shall prepare a sorted list of approved candidates and respective classification.

17. Panel's final decision shall be validated by the leader of the institution, who is also in charge of deciding about the hiring.

18. Application formalization:

18.1 Applications shall include all supported documents encompassed by section 7 and 8 for tender admission, namely:

a) Certificate or diploma copy;

b) Curriculum vitae, detailed and structured pursuant to sections 10 and 12, including the contact information of two referees

c) Other documentation relevant for the evaluation of qualifications in a related scientific area;

d) motivation letter (in English – mandatory)

19. All candidates who formalize their applications in an improper way or fail to prove the requirements imposed by this tender are excluded from admission. In case of doubt, the panel is entitled to request any candidate to present further documentation supporting their statements.

20. False statements provided by the candidates shall be punished by law.

21. Both admitted and excluded candidate list and final classification list shall be published in the website of the Institute and the candidates are notified by email.

After publication, all candidates have 10 working days to respond. Panel's final decisions are pronounced within a period of 90 days, from the application deadline, published at IBMC website.

The expected starting date is November 1, 2019.

22. This tender is exclusively destined to fill this specify vacancy and can be terminated at any time until approval of final candidate list, expiring with the respective occupation of said vacancy.

23.
