The introductory course is for researchers (including graduate students and research technicians) with no previous training in animal experimentation. Such training is a legal requirement to work with animals and a requirement for access to the IBMC animal facility.

The introductory course is available for persons that will develop work at the IBMC-INEB animal facility and associated external animal rooms at the IBMC building, at the subsidized fee of €75. Section B in the application form must be filled by the responsible PI attesting these conditions.

IBMC.INEB researchers who will not work at the IBMC.INEB animal facility will be admitted to the course if there is space, and at a fee of ≤ 300 .

We will not be able to refund fees paid in advance and not requested by us.

Course format:

The course comprises a theoretical (approximately 30 hours including e-learning) and a practical (10 hours) part with evaluation, where minimum grade requested is required for approval.
